From the AACC Bylaws Approved May, 2006

Article 1 MEMBERSHIP

Section 1.01

- A) The membership of AACC shall be open to individuals and organizations which further the purpose of AACC.
- B) Members may change from one category to another at any time.
- C) The membership fees shall be determined, from time to time, by the Board.

Section 1.02 Categories of Membership

A) Full

A Full member provides educational and training services at least one of which is currently a government designated program.

A **Full member** has the responsibility to:

- i Pay the membership fees on time and in full.
- ii Inform the AACC office of changes in contact information
- iii Attend membership meetings
- iv Abide by the Bylaws and the member Code of Conduct.
- v Actively support the vision, mission and goals of AACC.

A **Full member** is afforded the rights of:

- i Voice and one vote at all membership meetings
- ii Service as a Director on the Board
- iii Service as a Chair or member of any AACC committees
- iv Eligibility for all membership programs, benefits and services

An **Associate member** has the responsibility to:

- ii Inform the AACC office of changes in contact information
- iii Attend membership meetings
